RESTAURANT Definition: Any public place kept, used, maintained, advertised or held out to the public as a place where meals are regularly prepared and served, and where adequate provision is made for sanitary kitchen and dining equipment and a sufficient number of employees to prepare, cook and serve a reasonable variety of meals for its customers. The mere availability of snack items, prepackaged food items, or cold sandwiches alone shall not be sufficient to meet this definition, the intent being that meals consisting of more than one course shall be available at all times liquor sales are being conducted until at least ten o'clock (10:00) P.M. After such time, a reduced menu of appetizers, hors d'oeuvres or other similar foods may be offered. Food service must be provided continuously until one hour prior to closing.

1 to 50 seats	\$ 75.00

201 to 300 seats	\$ 225.00
301 and over	\$ 300.00

Grocery, Meat, Deli License Fees:

2 cash registers or less	\$ 50.00
3 to 5 cash registers or more	\$ 200.00
For each additional cash register over 5	\$ 50.00

NOTE: After July 1, Liquor Annual Fee, Restaurant & other business license fees are reduced by 50%.
