Main Street Beautification Program

The Main Street traffic trial ended on May 25, 2005 and the tubular lane markers have been removed. The traffic trial was conducted to help the Village analyze downtown traffic patterns to determine if Main Street could be narrowed to one lane in either direction with center turn lanes at the intersections. The Village's Master Plan recommended making this change to help create a more attractive, pedestrian-friendly downtown in order to attract more customers and businesses into the area.

During the next few weeks, the Village Board will continue to analyze

results and accept feedback about the Main Street Beautification Program in order to make an informed decision at an upcoming Board meeting.

I was pleased to participate in the opening of the Chicago Bandits professional softball season and look forward to the DuPage Dragons opener too. Having a professional women's softball team and a top tier collegiate baseball team playing throughout the summer at the Lisle/Benedictine Sports Complex is a great activity for the community. Hosting some of the activities for the Prairie State Games—our Illinois "Olympics"—from June 23-26 should also provide great recreational opportunities for the community, as well as many visitors to enhance our business community.

The Village Board created a task force this spring to examine possible approaches to address the high cost of water to residents in the Oakview subdivision. Their water and sewer service has been provided for many years by a private utility, now Illinois American, that has roots in this community and others. New refuse contract with BFI

The Village of Lisle has signed a new three-year contract licensing BFI for waste removal services for Village residences. The sticker system currently in place will continue. The Village has mailed out new Curbside and Multi-Family LEAP brochures with full details.

NEW! New in this contract is the option for yard waste only to be placed unbagged in a trash can (maximum 33 gallon capacity/ 60 lbs. weight). Residents still have the option of using kraft paper yard waste bags. Both options require a yard waste sticker.

For disposal of yard waste from a trash can, loop the disposal sticker through the handle of the trash can. This can easily be done by passing one end of the sticker through the handle, peeling off only the two end pieces of the backing, and sticking them together.

Yard waste decal. To designate a trash can for yard waste, BFI will supply long, rectangular shaped decals to Lisle residents at no charge.

Mosquitoes are coming!

Mosquitoes are an all too familiar summer nuisance. West Nile virus has already been identified in dead birds in areas nearby. This disease sickens people, as well as animals. Protect yourself from mosquito bites. Use repellent. Cover up. Limit exposure at dawn and dusk when mosquitos are most active.



Don't let your property breed mosquitos. Eliminate standing water. Change the water in birdbaths and wading pools weekly. Empty plant pot drip trays. Repair leaky outside faucets.

The Village of Lisle contracts with Clarke Environmental Management, Inc. of Roselle, IL for mosquito control. To report mosquito nuisances in your area, please call Clarke at 1-800-942-2555.

Residents must affix the permanent decal to one side of the garbage can to designate it as a container filled with yard waste. **The decal side of the can must face the street.** This indicates to the garbage truck driver that the can is yard waste and he should not stop his truck. Likewise, it tells the yard waste truck driver to stop for the yard waste.

Decals may be obtained at the Village Hall Business Office, or by calling BFI at 964-3232.

What value is this change to residents? Save the cost of yard waste bags, ~50¢ each. Also, bags sometimes get wet and fall apart, spilling grass or other contents. Avoid the mess!

Sticker costs are rising modestly. Residents may continue to use old stickers until July 31, 2005.

Mobile Driver Services Facility returning

Get your license or ID card right in town! The Secretary of State's mobile facility will be returning to Lisle on Friday, August 26, 2005 9:30 a.m. – 2:30 p.m. They will offer their services to the public at Village Hall, 925 Burlington Avenue. They will be serving groups only by pre-arranged appointment on Thursday, August 25th during the same hours. Call Barb Libby in the Village Manager's Office at 271-4115 to schedule a group.

They will provide driver's licenses, ID cards, and other services. License plate renewal stickers may be obtained only for the months past (July), present

(August), and upcoming (September). For driver's licenses, they will offer vision screening and written exams (excluding CDL). They can issue instruction permits, original driver's licenses, duplicate driver's licenses, corrected driver's licenses, and renewal licenses.

Bring appropriate proof of ID. For renewals, a current license or state ID card usually provides most of the data. A comprehensive list of acceptable forms of identification is listed on the new Sec. of State website: www.cyberdriveillinois.org.

Please mail or bring this application to the Village Hall, 925 Burlington Ave., Lisle, IL 60532. Mark the envelope "2005 Tree Program" on the front. Applicants will be notified as to whether the Village can plant a tree for them. The Village of Lisle reserves the right to cancel any order.

Application deadline is 5 p.m. Friday, August 19, 2005.

Cost-share Parkway Trees

A limited quantity of parkway trees will be available this year to property owners under the cost-share program. The trees cost the Village \$250-\$300 each, but are made available to residents for \$99 each. Depending on demand, applicants may, or may not, be limited to one tree.

Use the application form found here or download a copy from the Village's website (www.vil.lisle.il.us).

The Parkway Tree Planting Program provides trees for parkways that are directly adjacent to Village roads. **All of these trees must be planted in Village right-of-way.** Unfortunately, no trees can be planted along state or county-owned roads, or in areas where the Village of Lisle has inadequate right-of-way behind the curb. Arboretum Woods and some areas within Green Trails have no right-of-way behind the curb.

Public Works personnel will contact applicants and stake the location best suited for success of the trees based on the homeowners' suggestions and consideration of any conflicts with utilities, visual clearance, spacing requirements, etc. The trees will be planted after they go dormant in late fall.

Tree Descriptions

"Autumn Purple" White Ash

Pyramidal to rounded outline. Deep green leaves turn reddish-purple in the fall. Rapid growth rate: 45-50'

"Skyline" Honeylocust

Pyramidal-rounded canopy. Free of thorns and seeds. Tiny leaflets cast filtered shade. Golden yellow fall color. Medium growth rate: 45'

"Redmond" American Linden

Clean pyramidal crown. Fragrant flowers appear in June. Large, light green foliage. Yellow fall color. Medium growth rate: 35'

"Emerald Queen" Norway Maple

Ascending branches, oval to rounded crown. Dense shade and shallow roots compete with grass. Dark green leaves turn brilliant yellow in fall. Rapid growth rate: 45-50'

New sidewalks

Contracts will be let for the installation of new sidewalks later in 2005 at several locations:

- Front St. – south side, west of Westview
- Oakview Dr. – west side
- Meyer Dr. – west side, Gamble to Meadow

Estimated cost for this year's sidewalk installations is \$300,000.

The Village has now been approved for federal funding for sidewalk construction along Route 53 in 2006. The federal share will be 75%, with the 25% local share anticipated at ~\$125,000. The sidewalks will go on the west side, Main to Short, and east side, Rolling to Main and Short to Warrenville.

Widening I-88

Illinois State Toll Highway Authority is now beginning preliminary work for widening the Reagan Tollway to four lanes in each direction from Finley Road in Downers Grove to east of Washington Street in Naperville. In 2005 drainage work and temporary power for lighting fixtures will be underway. Road construction will begin in 2006. The Rt. 53 intersection will be reconfigured in the process.

Noise barriers (design concept on Village website) will be extended further to the east in response to resident comments made at the Lisle neighborhood meeting in September 2004; however, they will be installed at the end of the project. Completion is projected to take about 2½ years, with landscaping stretching into 2008.

Latex paint

disposal strategies

Keep painting! What better place to put that last pint than right up there on the wall where it blends perfectly? Let the empty can dry and recycle it.

Paint something else. Use up your paint on a piece of cardboard, scrap lumber, or the inside of your garage.

Use an absorbent. Kitty litter, sawdust, or shredded paper can be mixed into the paint to absorb the liquid. Dry the mixture out or dispose of it directly.

Give it away.

Store it for later. Make it last longer by covering the opening with plastic wrap, securely fasten the lid, then store upside down.

Free recycled latex paint

DuPage County has usable latex paint available for pickup. It has been dropped off by residents, inspected, sorted, filtered, and rebled into 5 gallon buckets of recycled paint. The end product is a quality recycled paint available in a variety of colors, types, and finishes. Call 985-7400 for info.



Pick up paint while supplies last:

Drop off paint. Latex (only) paint may be dropped off weekdays during the pick-up times listed above, plus on selected Saturdays: June 11 and 25, July 9 and 23, and August 13. Saturday drop-off hours: 8 a.m.– 2 p.m.

Solvent-based paints, such as oil-based, urethane, and epoxy paints may be disposed of at the Regional Household Hazardous Waste Facility, 1971 Brookdale Rd., (off Route 59) Naperville on Saturdays and Sundays, 9 a.m.-3 p.m.

Sprinkling restrictions in effect

From May 15th through September 15th, sprinkling of lawns and gardens is restricted to early mornings before 7:00 a.m. and evenings after 7:00 p.m. Even-number street addresses may sprinkle on even-numbered calendar dates; odd-number addresses on odd-number dates. Hand-held hoses may be used anytime.

Commuter station improvements

The Village of Lisle has been awarded a grant in the amount of \$50,820.00 for improvements at the Lisle Commuter Station.

- Restroom remodeling
- Non-skid floor applications
- New train station sign
- More ornamental fencing and gate
- Thermal window pane replacement
- Concrete work near the depot

This grant was made available to the Village of Lisle by the West Suburban Mass Transit District (WSMTD). The WSMTD is providing 2/3 funding for this \$75,850 project, which is beneficial to commuters and the passenger railway system in general.

Village of Lisle employee, Bill Glowienke, Facilities Manager, made the grant application, and will serve as the Project Manager. Completion is expected by year end.

Phone tax rebate

The Village of Lisle offers a flat \$25 phone tax rebate to senior citizens aged 65 or older and to the disabled. Residents are limited to one claim per household each year. The rebate applies to a primary phone, excluding cellular phones. Applications are received each year May-July.

Applications are currently being accepted at the Business Office for the period between May 1, 2004 and April 30, 2005. Applicants must qualify by age or disability during the rebate period. Bring two phone bills, the ones for May 2004 and April 2005. Otherwise, provide bills for any six months during that period. Bills must be in the name of the person applying for the rebate. Also bring proof of age (drivers license, state ID, or passport) or disability (Social Security form), and anything showing a current address. Application deadline is Friday, July 29, 2005. For additional info, call the Business Office at 271-4100.

Why do we repeat this information?

- 1) Publicizing this information annually is one factor in determining the Village's National Flood Insurance Program rating. This rating translates into flood insurance premium discounts for Village of Lisle residents.
- 2) Observe in the history section that there have been floods nearly every decade. We can't stop rain from falling, but we can act to control its impact.

You and the DuPage River watershed

If residents dump oil or antifreeze down a storm drain or on the ground, they are polluting the DuPage River. Water runoff picks up fertilizers, pesticides, detergents, pet waste, grass clippings, and oil and grease from vehicle drips.

Don't pollute our waterways!

This water drains through a collection system that includes swales, ditches, inlets, pipes, channels, ponds and creeks before emptying into the East Branch of the DuPage River.

Lisle is but one piece of a larger watershed. The East Branch starts near Bloomingdale and drains all or part of Bloomingdale, Glendale Heights, Lombard, Glen Ellyn, Downers Grove, Lisle, Westmont, Woodridge, and Naperville. The East Branch merges with the West Branch in Will County and eventually empties into the Des Plaines River in Channahon. Ultimately, Lisle's stormwater runoff makes its way to the Mississippi and the Gulf of Mexico.

Managing floods

The Village of Lisle is interested in providing floodplain information and protection to residents and business owners.

Flood history in Lisle. Lisle does have a history of flooding, usually in late spring or late summer. Flooding has been reported on the East Branch of the DuPage River in 1948, 1950, 1954, 1957, 1972, 1987, and 1996. The August 1972 flood was the flood of record, and the most damaging in the area. The most recent flood of 1996 was primarily controlled by levees constructed along the river in the mid-1960s and the floodplain design and development controls imposed by the Village since 1970.

Is your property affected? The Village maintains maps of floodplain areas and the flood insurance study for the Village of Lisle. The Village enforces its floodplain regulations and the DuPage County Stormwater and Floodplain Ordinance. Mary Lou Kalsted, P. E., CFM, (630-271-4107) is Village of Lisle Floodplain Coordinator and is available to answer any questions concerning floodplain regulations, and flood protection measures. Upon written request, Ms. Kalsted will provide floodplain determination letters for any property within the Village limits free of charge.

Insurance. Flood damages are not normally covered by regular homeowners insurance. However, separate flood insurance may be purchased for structures and personal possessions. The insurance premium rate depends on the depth of flooding that might occur on your property in a 100 year flood. Because of strict enforcement of Village regulations and

other activities to meet FEMA standards, owners of property within the Village of Lisle which is in the flood plain are eligible for a 15% reduction in premiums.

The Village of Lisle is a participant in the National Flood Insurance Program, so *any* property owner in Lisle may purchase flood insurance. Flood insurance is *required* only for properties in the 100 year flood zone that are purchased with federally guaranteed funds (i.e. FHA, VA, FSLIC).

Information available.

Additional information on flood insurance coverage and requirements, flood protection measures, flood safety, and property and building protection is available in a floodplain library maintained by the Village of Lisle both at the Village Hall and at the Lisle Library. Property owners can take actions in advance of a flood to provide protection for their property. The helpful FEMA publications "Flood Emergency and Residential Repair Handbook" and "Design Manual for Retrofitting Flood Prone Residential Structures" are in these libraries, as are several other useful documents.

When floods come. In the event of an actual flood situation, there should be sufficient warning for people in affected areas to take precautions or evacuate. Lowest openings to a home (basement windows, crawl space) could be sandbagged and personal possessions could be raised above basement and first floor levels. Furniture and appliances could be enclosed in plastic. Gas, water, and electrical services should be shut off.

However, when told to evacuate by emergency personnel, do so. Flood waters run deceptively smoothly, but contain great forces. They can rise dramatically in a short time, cutting off escape routes. While some streets in Lisle would flood, and indeed some are designed to be stormwater overflow routes, all areas of town will have open streets suitable for evacuation.

Why and what of floodplain controls

Approximately 20% of Lisle properties are in or adjacent to floodplain areas, as identified by the Federal Insurance Administration. Several streams run through Lisle, including Willoway Brook, St. Joseph Creek, Rott Creek and St. Procopius Creek, and Lisle is bisected by the East Branch of the DuPage River. Storm sewers, swales, drainage ditches and detention/retention ponds also play an important part in overall stormwater and floodplain control. Controlling development so as to maintain these waterways is extremely important to the Village of Lisle.

Why protect the floodplain?

Floodplains in their natural state have an important impact on flooding. Flood waters can spread over a large area in floodplains that have not been encroached upon. This reduces flood velocities and provides flood storage to reduce peak flows downstream, and also reduces the frequency and duration of low flows of surface water.

Natural floodplains reduce wind and wave impacts and their vegetation stabilizes soils during flooding. They can act as recharge areas for groundwater, and water quality is improved in areas where natural cover acts as a filter for runoff and overbank flows. Sediment loads and impurities are also minimized. Natural floodplains moderate water temperature, reducing the

possibility of adverse impacts on aquatic plants and animals. They provide habitat for diverse species of flora and fauna, some of which cannot live anywhere else. They are especially important as breeding and feeding areas. Community Park is one area that serves this purpose in the Village of Lisle.

Drainage Maintenance. Many properties include drainage swales or ditches within their boundaries. It is illegal to grade, excavate or fill in any property in the Village of Lisle without

a proper permit. Private property owners are also responsible for maintaining any ditches or streams on their property, keeping them clear of obstructions including brush, debris, and grass clippings. Even a small project, such as a raised flower bed or a shed, can block drainage paths and cause immediate localized flooding problems. If you witness any potentially illegal dumping, filling, or construction, you may contact the

Village of Lisle Building and Zoning Department at (630) 271-4150.

Plan review and permits. Since 1970 the Village of Lisle has been active in floodplain development regulations. Village code requires that the lowest floor of any structure be at least two feet above the flood plain. However, many Lisle homes were built before floodplain regulations went into effect. Floodplain considerations may limit changes or additions to those properties. Any new work or substantial remodeling in excess of 50% of the building's market value requires elevating the structure two feet above the flood plain. This is a cumulative requirement for repairs conducted in successive years. Work that requires a permit includes work outside, such as decks, sheds, regrading around projects such as raised flower beds, etc.

Plan approval and permits are required for any developmental work within the Village of Lisle, whether the property is in the floodplain or not. The Village does enforce floodplain and stormwater regulations to ensure property protection from possible localized flooding damages. When planning any work, please contact the Village of Lisle Building and Zoning Department at (630) 271-4150 concerning code and permit requirements.



Former Village Hall site development

The process to develop the site of the former Village Hall continues.

During the June 13th workshop session, Village consultant S. B. Friedman presented the results of a site-specific market analysis which identified the types of businesses. He lead a discussion about possible uses for the site. Per the Board's request, he also discussed using the property for a civic use, such as a park.

It is anticipated that the Board will continue discussions with Friedman during the June 27th meeting. Once the Board determines the specific use for that site, Friedman will continue his work. If the Board chooses to pursue a commercial focus, Friedman will create more detailed site plans and then begin the process to help select a developer who will build on the site. As always, the public is invited to attend and participate in these sessions, which begin at 7:30 p.m.
